The Chairman's Awards of Excellence 2011

The Awards of Excellence are given to companies that sustain comprehensive support of United Way of the Greater Triangle and represent the highest standards of excellence. There are three Awards of Excellence, one for each of the following areas:

- **Employee Campaign Performance**
- **Corporate Involvement and Support**
- **Employee Education and Volunteerism**

In addition, the company that best demonstrates excellence in all three of the above areas will be the recipient of the award for:

- **Best Overall Performance**

Eligibility

Any company that meets the specific criteria on the Nomination Form is eligible to enter in 2011.

How will the recipients be nominated?

By company self-nominations, or by recommendations from campaign volunteers and United Way of the Greater Triangle staff.

How will the recipients be chosen?

Nominations for the Awards of Excellence are reviewed by a panel of community volunteers. This panel makes recommendations for the winners of the three awards to the Campaign Chairperson, Doug Vinsel. In addition, the panel makes a recommendation based on the submitted nominations for the highest award, Best Overall Performance. Doug Vinsel will make the final selection.

How will the award recipients be notified?

Each award recipient's Chief Executive Officer or top local executive will receive a congratulatory call from Doug Vinsel.

Award Ceremony and Recognition

United Way of the Greater Triangle will formally recognize winners during the organization's annual celebration in 2012. Recipients will also be recognized through United Way communications including publications, year-round marketing materials and news releases to the media.
